ELIGIBILITY

Must be 18 and older. All WV residents and all TSAA members.

CATEGORIES

Original fine arts produced since January 2020. Film making and video not eligible for this competition.

ENTRY REQUIREMENTS

1. Works not shown in any previous AAWV juried exhibition.
2. Each artist may submit three works.
3. Hanging 2D art and 3D works not to exceed 6' x 6'.
4. Suspended objects cannot exceed 65 lbs. Please note: Ceiling suspended objects not eligible for this exhibit.
5. Works must be properly wired for hanging.
6. Plexiglass required in place of glass except for on pastels.
7. Artists must allow all accepted works to be photographed and used for publicity purposes.

NOTE: Paintings created from photo images must be of original sources (property of the entering artist). Sources must not be from copyrighted materials including Internet sources or appropriated/copied from other art. Work created in a workshop is not allowed.

AGREEMENT

The Parkersburg Art Center will insure artwork while on site at the Center. Artists are responsible for any loss or damage to artwork during transit to and from the Center. The artist's signed entry form shall constitute agreement to comply with all conditions of this Prospectus.
